Ways to obtain Full Hong Kong Driving Licence

There are three ways to obtain the Full Hong Kong Driving Licence, they are:

1) Driving Test Application

Driving Test is the standard approach through Written Test and Road Test. Written test also known as Part A and Road test consists of two parts namely Part B and Part C, together named Combine. Applicants submit application for Written Test Appointment to start.

Written test consists of 20 simple multiple choices. Applicants have 20 minutes to answer the questions. Minimum score 16 out of 20 to pass. Written Test postponement need to be submitted 10 working days in advance. If passed, the applicant will be advised to pick up their Road Test Schedule Form, otherwise, the applicant can submit an application for a new Written Test Appointment by next working day.

Road Test Part B conducts in the test centre and consists of three sections include parking, narrow road turn about and starts and stops on slope. Road Test Part C conducts in the live driving environment on every aspects. Learner's Driving Licence is needed for driving classes (Transport Department recommend 30 hours). Road Test postponement or Change of Test Region has to be submitted 10 working days in advance before test. If the applicant failed in either part of the road test, just need to retake the failed part by purchase a new corresponding Road Test Schedule Form, otherwise the applicant need to purchase a new combine Road Test Schedule Form. The new Test Schedule Form could be purchased 10 working days afterwards.

If the applicant passed the Part A, B and C of the driving test, after 10 working days, could apply for the Probationary Driving Licence which will expire in 1 year and renewable for 6 months if needed. The applicant could apply for the Full Hong Kong Driving Licence after obtained the Probationary Driving Licence for a year or after expired not more than two years.

2) Temporary Driving Licence Application with Driving Test

If an applicant has a valid driving licence from a country or place that <u>not listed</u> under the Schedule 4 of Road Traffic (Driving Licence) Regulation Cap. 374B and within three months after his/ her arrival in Hong Kong to take up his/ her residence, has applied the Hong Kong driving test, could apply a Temporary Driving Licence to drive in Hong Kong for a year starting from the date they take up residence or the driving licence expires which ever occur first. If the applicant one take passed the driving test, could apply for the Full Hong Kong Driving Licence. If failed at any part of the driving test, the Temporary Driving Licence will be revoked.

3) Direct Issue of Full Hong Kong Driving Licence Application

If an applicant has a valid or expired not more than three years driving licence from the issuing country or place that <u>listed</u> under the Schedule 4 of Road Traffic (Driving Licence) Regulation Cap. 374B, could submit the application for a direct issue of a Full Hong Kong Driving Licence.
